



Privacy Statement



This privacy statement clarifies how Venation uses and protects information you provide when using our website. It could be that our statement is updated since the last time you visited our website, the latest version is always available via www.venation.digital.

What we collect

As a visitor to our website, you can browse and find out more about Venation. You are not required to provide us with any personal information as a visitor. We leverage first and third-party cookies to collect information from our visitors (more on this later).

You may contact us through our contact form, we then collect the following information:

- Email address
- Name
- Company information

What we do with the information we gather

- Keep the details should you expressed interest in us and in our current & future services
- Use contact information to provide you our inside information or pricing quotes
- Use it to provide you service specific information
- Tune & improve our offering and website

Now there's a couple of topics we want to bring to your attention:

Cookies in general

Website cookies allow web applications to respond to you as an individual, by storing a small file on your computer. We use traffic log cookies to identify which pages are being used. This helps us analyze data about web page traffic and improve our website to tailor it to your needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Third-party cookies

When someone visits www.venation.digital we use third-party services called Google Analytics & Hotjar. Web analytics services offered by Google and Hotjar that track and report website activity. We use the service to understand our website usage so we can tune our offering and the website. This information is anonymized, and we do not make any attempt to find out the identities of those visiting our website. A detailed list is available on request.



Links to other websites

Our website may contain links to other websites of interest. Just know that once you leave our website, we don't have any control over that other website. Therefore, we cannot be held responsible for protection and privacy of any information you provided whilst visiting sites not governed by this privacy statement.

Your rights
